
Mission Statement

HISTORY OF THE VIRGINIA SOCIETY OF ENROLLED AGENTS

On October 25, 1983, a pre-organizational meeting was held at NAEA Headquarters in Washington, D.C. to form the Virginia State Society. Present at that meeting were: Judith Beach, Vernon Graber, Edward Levine, Lewis Marsh, Bess Messmer, Robert Spencer and Jack Wade.

An organizational meeting, open to all Virginia Enrolled Agents, was held at the Richmond Hyatt, on November 17, 1983.

Attendees were David Barrach of NAEA, Bette Conlon, Edward Levine, Thomas Litton, W. Stuart Logan, Bess Messmer, Robert Mitchell, Benny Montgomery, Helen Ruther Salomon, Robert Spencer, Jack Wade, Roy Williams and Vernon Woodward. So much interest was shown at this meeting, the attendees decided to proceed with the incorporation process and affiliation with NAEA. Minutes of the meeting made up the first issue of the "Virginia Enrolled Agent" newsletter in November, 1983.

The following volunteered to serve the Society and are listed in the Articles of Incorporation dated November 28, 1983 as Initial Directors: Bette Conlon of Fredericksburg, Edward Levine and Robert Spencer of Richmond, Thomas Litton of Lexington, Bess Messmer (Incorporator) of Colonial Heights, Robert Mitchell, Jr. of Vienna, and Roy E. Williams of Annandale.

The Certificate of Incorporation was issued to the Virginia Society of Enrolled Agents, a non-profit, non-stock corporation, on December 1, 1983. The fiscal year was designated as July 1 - June 30. There were 20 original members.

The Inaugural Meeting of the Society was held on December 13, 1983, at the Ramada Inn in Carmel Church, and the following decisions were made:

VASEA "Firsts"

The *first* General Membership Meeting was held on May 24, 1984 in Richmond. Thirty attendees earned 3 hours of Continuing Professional Education (CPE) credits.

The *first* speakers were: Edwin A. Kelleher of the IRS District Office, Edgar G. Hobson, Jr. of the Virginia Department of Taxation, Frank D. Tehel, EA, CFP, and Leah K. Herzberg, EA, Director, NAEA.

The *first* annual VASEA Convention was held in Lynchburg in October 1985.

The *first* educational seminar was held October 11, 1984 at the Holiday Inn Holidome, in Fredericksburg. The *first* "early bird" registration was offered for this seminar.

On June 7, 1985, VASEA held the *first* all-day educational seminar at the Holidome, in Fredericksburg. Eight hours of CPE were offered to the 48 participants.

The *first* Annual VASEA Convention was held in October 1985 at the Radisson Hotel in Lynchburg.

The *first* issue of the "Virginia Enrolled Agent" newsletter was launched in November 1983. Four issues were published that year, and every year since. The *first* issue to use the name, "Virginia Voice" was published in January 1991.

The *first* Governor to recognize the Virginia Society of Enrolled Agents was Charles S. Robb who issued a Proclamation designating July 1 - 7, 1984 as National Enrolled Agents Week. George Allen followed suit with a Proclamation in 1994, and issued a Certificate of Recognition for the 110th Anniversary of the Enabling Act, the beginning of Enrolled Agents.

The *first* official abbreviation changed from VSEA to VaSEA in 1990, then to VASEA in 2003.

VASEA ACCOMPLISHMENTS

Over the years, the Virginia Society of Enrolled Agents has many accomplishments to be proud of:

- Continuing Education is a top priority! VASEA and its local chapters sponsor more than 150 CPE hours each year:
 - At annual seminars
 - At annual conventions since 1985
 - As partners with NCPE, NTPI, PTI, and AT&T
 - At local chapter meetings
- VASEA compiles and distributes quarterly newsletters and annual Membership Directories in an effort to keep its membership informed. The newsletter title, "Virginia Voice" was registered in the records of the Patent & Trademark Office September 26, 1995.
- VASEA has been actively involved in liaison meetings with representatives from both the IRS and the Virginia Department of Taxation since 1987.
- VASEA conducts SEE preparation courses originally conducted by the Northern Virginia Chapter in 1989.
- VASEA membership has grown from 20 original members in December 1983, to 338 Members and 83 Associates today.
- VASEA has been on the cutting edge of computer technology, and computerized tax preparation since July 1986 when the first meeting with the IRS to participate in Electronic Filing was held in Hampton Roads. Over the years, the Society has sponsored many seminars on computer use and tax software.
- Two NAEA Presidents hailed from Virginia: Bess Messmer, EA, and Jim Reames, EA. Cynne White Wolf, EA, Sherry Loop, EA and Toni der Boghossian, EA, ATA have served on NAEA committees.
